And The American Legion County Fair Premium Book (ALCFPB)

The Following Rules And Regulations

With Additional Species-Specific Information As Applied By The Barn Superintendents Will Apply.

Exhibitors Must Abide By The Department Of Agriculture's Health Requirements

And Any Additional Requirements As Set Forth By The American Legion County Barn Superintendents.

Registration has payment enabled online and is required during the order process.

**Saturday August 22<sup>nd</sup> - Noon to 3 pm. Monday thru Friday Aug. 24 – 28 - 9 to 5 pm.**

**(SPGB)** As a Fair that receives Fair Program Grants from the Pennsylvania Department of Agriculture we are bound to conform to the Departments State Premium Guideline Book.

Not all Departments or Classes need to be included within if the fair does not offer exhibits within those Departments. By the same procedure fairs may add classes and not be censured. Department additions are not acceptable.

The State Premium Book has been arranged so that fairs may incorporate all or parts of it in their individual Fair Premium Books. All fairs who receive Fair Program Grants shall conform with this book when preparing their Premium Books. This means you shall follow the position of a Department as shown. You need not show any Departments for which you do not want exhibits.

All animals admitted to (show or fair) shall be identified by a unique and permanent ear tag, tattoo, brand or records of unique physical attributes; Animals known to be infected with or exposed to any contagious, infections or external parasitic disease, and animals restricted by quarantine may not be assembled for show purposes.

## **GENERAL RULES, REGULATIONS & INFORMATION**

All animals admitted to (show or fair) must comply with applicable State (7PA Code) or Federal (CFR) rules. All cloven-hoof animals, not subject to 7PA. Code or 9 CFR, including members of the deer and camelid families, shall have been born in Pennsylvania or resided in Pennsylvania for at least six (6) months and shall be brucellosis and tuberculosis tested (negative) by an accredited veterinarian within 60 days of admission to the show.

Animals presented for exhibition will be subject to inspection by show officials and will be rejected if evidence of infectious, contagious or parasitic disease is apparent or if health certification or identification documentation is not acceptable.

All show animals should be held in isolation for at least 30 days after returning to the herd of origin.

Each exhibit accepted for premiums must be given an entry tag which must be properly marked to show the name of the exhibit. In the case of livestock, breed name must be shown on cards large enough so that the breed name can be readily identified by the viewers.

If Livestock is grouped together according to breed, one large sign to designate the group will be satisfactory. Ribbons and / or rosettes must be placed on the stall or pen of the individual winners for the duration of the Fair or Show. In the case of poultry, Entry Tags Showing Species must be exhibited on each cage, and winning stickers must appear on each Entry Tag showing winners. Failure to comply with this regulation will result in Forfeiture of Premiums. It shall be the duty of the Fair or Show officials to enforce this regulation.

Reasonable care will be taken to protect all exhibits on display from all injury and damage, but the fair is not in anyway, to be held responsible for accidents, loss or damage by water, fire, theft, or otherwise, whatever may be the cause or extent of the damage or loss.

**Fair Management reserves the right to amend or add to these guidelines as its judgment may determine. (SPGB)**

Entries will be made according to classification.

Joint ownership is as one owner in accordance with registration papers.

The Fair reserves the RIGHT TO DETERMINE how many entries they will accept from an exhibitor in the same class or, in the case of livestock, the same breed, and poultry the same species.

THE DECISION OF THE JUDGES SHALL BE FINAL IN ALL CASES except where mistakes, fraud, misrepresentation, or collusion not discovered at the time of the award is proved. In such cases the Superintendent, Manager, or Secretary of the Fair or Show, or such referee as he may appoint, may make the decision. The case may be appealed to the Fair Management or Show Commission, from whose decision there can be no appeal. All protests regarding the judging must be made in writing and must plainly state the cause of the complaint or appeal. Such protests must be filed at the Fair Office within 24 hours of the occurrence.

**(ALCFPB) It Is The Responsibility Of The Exhibitor To Read And Be Aware Of All The Rules, Regulations And Additional Information Concerning Exhibition At The American Legion County Fair. Health Paperwork for all Livestock will be checked and both State and Fair Rules will be enforced.**

All Livestock and Livestock Paperwork will be checked by Species Barn Superintendent and or Board of Directors or other designated individuals upon entering the Barns. Any questionable health concerns or paperwork will be examined by the Veterinarian appointed by the Fair Board of Directors, who may be called at the expense of the exhibitor.

All Livestock will be weighed directly off the truck/trailer at their individual Species assigned times. **Identification will be verified upon arrival at the Fairgrounds. Every effort will be made to get the animal off the truck/trailer as quickly as possible. However, please be prepared to keep your animals comfortable if warm weather is a factor.**

It is the right of the Species-Specific Barn Superintendent and/or the Veterinarian to order the removal of any animal or animals in question.

It is the right of the Agriculture Building Superintendent or Co-Superintendent to order the removal of any exhibit unfit for competition (soiled, torn, stained, rotted etc.).

The American Legion County Fair prohibits direct criticism or interference with a Superintendent, Judge, Fair/Livestock Show Management, Show Officials, Breed Representatives or Other Exhibitors before, during, or after the competitive event. In carrying out the responsibilities of their official duty, All Judges, Fair and Livestock Show Management, or Other Show Officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them. False representation, or un-sportsman like conduct on the part of the exhibitor, will be dealt with by the Barn Superintendent. resolution

All protests must be in writing and must plainly state the cause of the complaint or appeal. The protest/appeal will be given to the Barn Superintendent or Co-Superintendent if the Superintendent is not available, who will then forward the protest/appeal within 4 hours to the Board of Directors who will decide the action needed to resolve the issue.

If an animal's age is brought into question the protest must be filed on the day prior to the one on which the animals are to be judged.

**Any Animal entered in the Livestock Show/Sale shall not receive any treatment with drugs or biologics within the withdrawal time prior to slaughter.**

**The Fair Reserves The Right To Blood Test Any Animal Suspected Of Illegal Treatments During Fair Week. If upon slaughter, a recent treatment with drugs or biologics is found to have been administered prior to the sale and is the cause of condemnation of a carcass, the loss of the carcass will be borne by the exhibitor.**

**(SPGB)** It shall be the responsibility of the exhibitor to Properly Name the Article or Breed of livestock he/she is entering. Any exhibit improperly entered will be disqualified to receive a premium, but the judges may make the correct name on the entry tag for the benefit of the owner so the same mistake in entering not be made a second time.

Market animals should be weighed on the same set of scales certified under a qualified weight master under the direction of the fair.

Should any animal awarded a prize be disqualified, the animals gaining the lower prizes shall move into the next higher position, if in the opinion of the judge, the animals are worthy of such prizes.

**Overfitting of cattle is discouraged. Any artificial means used to change the form or shape of an animal will disqualify it from competition.**

**(ALCFPB) 2026 FITTING RULE FOR 4-H AND OPEN CLASS ANIMALS Will Be Bath/Blow/Brush (Only).**

All youth are expected to groom and fit their own animals to the best of their ability, allowing for a more level playing field for exhibitors. Immediate Family Members, (Father, Mother, Sibling), Cambria County 4-H Leader of their Club, or a Current Cambria County 4-H Exhibitor With Knowledge Of The Animal Being Fitted, May Assist.

**Bath/Blow/Brush means that animals can only be groomed using a blow dryer and basic brushing techniques, without the use of any adhesives, paint or other artificial enhancements to alter their appearance. All clipping must be done at home prior to weigh-in.**

**After weigh-in livestock may not be clipped with any clipper device for any reason this includes, scissors, nail clippers, toe nail clippers etc.**

### GROOMING:

- ◇ **Animals will be shown free of any adhesive, glue, paint, or powder products.**
- ◇ **Animals may be washed, blown, brushed or combed to enhance their appearance.**
- ◇ **Any compounds that alter the color of the animal are not permitted.**

### LIVESTOCK

Animals unethically fitted to alter the conformation or appearance of the animal, as determined by the Barn Superintendents and their Co-Superintendents and, additionally, in the case of 4-H exhibitors, the 4-H Livestock Coordinator, will be disqualified at the Species Show in which the violation occurred.

Unethical fitting means any alteration of the natural appearance, conformation, musculature, or weight of an animal by any unnatural means. Such alterations do not include common and accepted animal husbandry practices such as combing or blowing the hair forward. Animals showing any signs of being unethically fitted will be subject to disqualification. The Fair Board of Directors with Input from Superintendents and Co-Superintendents and in the case of 4-H exhibitors the Penn State 4-H Livestock Coordinator will determine whether an exhibit has been unethically fitted and may, in its sole discretion, disqualify the exhibit. Such determinations are final and binding on the exhibitor and not subject to appeal.

#### EXAMPLES OF UNETHICAL FITTING INCLUDE, BUT ARE NOT LIMITED TO THE FOLLOWING:

- ◇ **Application of any substance to any part of the animal's body, unless specifically allowed in the department rules of that species.**
- ◇ **Injection, drenching or application of any substance per rectum is prohibited.**
- ◇ **Use of injections Draining of fluids Brusng Feeding of material not conducive to the health of the animal, safety of food or marketability of its carcass.**
- ◇ **Surgical alterations**
- ◇ **Artificially filling animals by stomach pumping or airing injections.**
- ◇ **Alternative treatments including but not limited to: Acupuncture, Massage Therapy, Therapeutic Laser.**

**(SPGB)** All Entries Must Have Been Grown, Produced, Made Or Raised Since The Last Fair By The Person Whose Name Appears On The Tag As Exhibitor. If Entries Are To Be Limited To Residents Of The County, Or To A Specified Area, This Must Be Stated In The Premium Book In The Rules And Regulations Section. **All Livestock Offered For Premiums Must Have be The Property Of The Owners For Thirty (30) Days Or Longer. Health Papers Are To Be Issued In The Name Of The Exhibitor.**

Superintendents Reserve The Right To Bar From Competition Any Entry Of Inferior Quality And Those Not Possessing Sufficient Merit To Warrant Recognition.

The fair reserves the right to remove any exhibit not worthy of viewing by the public.

Department Superintendents May Enter Exhibits In Their Own Department, but neither they nor any other exhibitor may communicate with the judges during the time of determining the awards, except to answer questions proposed by the judges.

When on exhibition in the ring, each animal must be under halter in charge of owner or employee. The fair will have stand-by attendants available during the youth judging or showing in the event of trouble.

**(ALCFPB) No person other than those holding animals being exhibited will be allowed in the Show Ring during the time of judging apart from the Judge, Show Stewards and any Accredited Media.**

**(SPGB)** Premiums, as listed, may be given for meritorious exhibits. In cases where there is no competition, judges may give an award such as they deem the exhibit is worthy to receive. The same rule applies where there are fewer entries in any class than the number of premiums offered. The judges may, at their discretion, award a ribbon or rosette. Any exhibitor may be required to prove their ability to reproduce the entry in any department in the presence of a qualified person. Where award ribbons are stolen or destroyed, the exhibitor may receive a duplicate at the close of the fair or show which will be supplied by the fair free of charge.

Food products cannot be treated with any substance that causes them to become poisonous and unfit for consumption. Any incident must be reported to the Pennsylvania Fair Program for further review.

## GENERAL RULES, REGULATIONS & INFORMATION

No exhibit may be removed at any time before the closure of the fair except by the consent of the management of the fair.

Judging is viewed as an educational process and the public is encouraged to view the judging event. Any exhibitor interfering with the judges shall forfeit any premiums to which he/she would otherwise have been entitled. Each fair is to implement this effort based on available space.

It is intended that each fair shall add or delete classes in which they perceive to be their own best interest and shall not jeopardize premium reimbursement set forth in each Section of each Department.

It is permissible for each fair to establish Supreme Champion Classes.

**(ALCFPB) It Is The Responsibility Of The Exhibitor To Care For Their Animal/Animals Entered In For Exhibition. It Is Not The Responsibility Of The BARN SUPERINTENDENT.**

The Exhibitor is responsible for cleaning their stalls daily and upon the exit of the animal. Failure to comply will result in Premium Checks being held until the issue has been taken care of.

Livestock must be kept clean, properly bedded, fed and watered while on fair property. Bedding will not be provided.

**All Livestock Barns are Non-Smoking Facilities.**

Livestock Barns will be open and available for cleaning and decorating prior to fair opening. Check with the fair office for dates and times. Decorations must be tasteful, neat and attractive. Exhibitors are responsible for up-keep and maintenance of their stalls/pens during fair week. Upon the exit of your animal, it is your responsibility to clean stalls, it is not the Superintendent's job or the job of the fairs ground crew. Failure to comply will result in the withholding of premium checks until the stall has been cleaned.

Livestock Pens or Stalls may not be altered in any way unless authorized by the Breed Specific Barn Superintendent, who will then contact the appropriate maintenance personnel to address your needs.

**MANURE ONLY MUST** be dumped in the designated Pit Area Only. Other trash it to be put in the trash cans distributed throughout the Fairgrounds.

Livestock Barns will close daily to the public at 10:00pm. Exhibitor may have access to their animals with the approval of the Species-Specific Barn Superintendent or Co-Superintendent.

**All Livestock** are not permitted down the Midway.

**The Signature of The Exhibitor on The Entry Form Confirms That the Exhibitor Liability Statement Below and the Code of Show Ring Ethics Has Been Read and Agreed To. Any Child Under the Age Of 18 Must Have a Parent or Guardian Signature. Entry Forms Will Not Be Accepted Without the Signature.**

**I Understand That As An Exhibitor I Am Solely Responsible For Any Loss, Injury, Damage Done Or Occasioned By Or Arising From Any Exhibit I Have Entered. I Shall Indemnify And Hold Harmless The American Legion County Fir Against Such Loss, Injury Or Damage.**

**Violations of the Livestock Rules & Regulations will be subject to disciplinary actions.**

1. The exhibitor will be given a verbal warning.
2. The exhibitor will be given a written warning.
3. The exhibitor will be pulled from the class/show.

**Superintendents will consult with the Fair Board for guidance on any action needed if actions 1 & 2 do not resolve the issue in question.**

All registrations both Livestock and Ag Building must be on the Current Year's Entry Forms and Associated Fees must be in the office for processing or postmarked by the designated due date. Entry Fees are Non-Refundable, exceptions are, the withdrawal of an entry before the entry closing date, or lack of available space.

Federal Law requires reporting of all premium awards over \$600.00. Premium checks of \$600.00 or more will need a Social Security Number to be received. The Fair will issue a 1099 for taxes.

**PREMIUM CHECKS ARE VOID AFTER 90 DAYS.**

### **PETS ARE NOT PERMITTED ON FAIR PROPERTY:**

The Only Exception Is A Registered, Certified And Documented Service Animal.

#### **Service Animals As Of The ADA (Americans With Disabilities Act)**

Individuals who have service animals are not exempt from local animal control or Public Health Requirements.

Service animals are subject to local dog licensing and registration requirements.

#### **Emotional Support Animals Are Not Service Animals And Are Not Permitted On The Fair-Grounds As per the Pennsylvania Department of Agriculture Requirements for In State Pennsylvania Dogs:**

Animals must be a registered, certified, and documented service animal with verification (a copy is acceptable) of current rabies vaccination.

#### **As per the Pennsylvania Department of Agriculture, Requirements for Out of State Dogs:**

Proof of current rabies vaccination (a copy is acceptable).

A Certificate of Veterinary Inspection (CVI) written within the 30 days prior to entering the fairgrounds.

### **PA STATE & NATIONAL CODE OF SHOW RING ETHICS**

Exhibitors of animals at livestock shows shall always conduct themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured competition classes. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show

Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial & national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.

Owners, exhibitors, fitters, trainers or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.

Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.

Animals shall be presented to show events where they will enter the food chain free of drugs. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event.

If the laboratory report on the chemical analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed

that the sample of urine, saliva, blood, or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal

in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise at any hearing in regard to the matter conducted by the fair or livestock show. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications shall be administered by a licensed vet.

Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.

The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.

Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.

No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.

The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.

The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have any disciplinary action taken by the fair or livestock show against such individuals published in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.

The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the "IAFE National Code of Show Ring Ethics" and understands the consequences of and penalties provided for actions prohibited by the code. It is further

a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

### **VEHICLE/TRAILER RULES & INFORMATION**

Trucks/Trailers unloading livestock on Saturday are required to use the WEST GATE (Livestock Side) and may unload on either side of the respective barns exiting out of the EAST GATE to the trailer parking area. Those unloading on Sunday MUST ENTER FROM THE WEST GATE AND EXIT THROUGH THE WEST GATE.

To avoid congestion, drivers are to move trailers outside of the grounds as soon as the animals/tack are unloaded.

1. Safety is of the utmost importance and all drivers must adhere to **the 15 mph speed limit**.
2. Horse trailers are to be kept outside the WEST GATE and horses are to be walked into their designated barns.
3. Livestock Trucks and trailers must park against the fence on the left side of the road outside the Livestock Gate and use the back road when going to and from the barns and arena.
4. Livestock Exhibitor Vehicle Stickers must be attached to the driver's side of the windshield allowing an unobstructed view of the sticker by Security.
5. Vehicle Stickers permit vehicles to enter the grounds for a 15-minute time period **before gates open to the public** to unload feed and supplies.
6. Motorized vehicles of any type for use on the fairgrounds must be registered and have authorization from the fair office.
7. Violators will be subject to having their vehicle towed at their expense, being removed from the fairgrounds and losing vehicle privileges the following fair year.
