All Camper/Tent Occupants Must Have A Lanyard

Camper/Tent Occupants Limited To 8 People Per Camper

Children Under 18 Must Be Under Supervision Of Parents Or Guardians

Campers/Tent Must Be Self Contained

Campers May Use 1 Air Conditioner

The Fairgrounds Has No Dumping Station

Camper Size, Slide Outs & Cell Phone Numbers Are Necessary

Vehicles Must Be Parked In Parking Area Outside The Gate And Not On Or At The Camper On The Fairgrounds
