Show Birds May be Exhibited at the 2025 Fair
Show Birds Will Remain On Fairgrounds The Entire Week Of Fair
4-H Market Birds Will Come In On Wednesday Evening
Leaving Saturday After The Market Sale.

Live Poultry Will Be Exhibited In The Dairy Cattle Lean-To / Open Class Goat Barn
Nesting Boxes And Poultry Posters Will Be Displayed In The Ag. Building Annex.
Intake Of Nesting Boxes And Poultry Posters – Friday 5–7 pm In The Ag Annex.

POULTRY

1. Nesting Hens are not permitted.
2. Pen space is limited and will be "First come First Served"
3. Entries will be accepted until the Cooping Capacity is reached.
4. All Poultry must have a PDA approved individual Identification Leg Band.
5. An Owner-Endorsed Poultry Health Certificate or Certificate of Veterinary Inspection (CVI) completed within 30 days of check-in and the **BLOOD DRAW RESULTS MUST BE PRESENTED DURING CHECK-IN.**
6. Avian influenza and Pullorum-Typhoid Testing is required. Verification of this test must be dated within 14 days of check-in
7. More than 1 Bird of the same variety if owned by the same exhibitor or exhibited by a different owner from the same flock may be placed in one coop together.
8. A bird may compete for only 1 prize except for Special Awards.
9. Birds must be taken care of daily by the Exhibitor. Ducks must be provided bowls.
10. All Birds must be the property of the exhibitor.
11. All Poultry exhibits must be labeled with an Exhibitor Card showing ownership, sex, class and breed of bird.
12. Substitute chickens may be used if cleared through the Barn superintendent and properly leg banded and tested.

SECTION 802 – MEAT CHICKENS

1. One Entry Per Exhibitor. One Meat Chicken Entry consists of 2 Birds.
2. Exhibitors may Leg Band 4 Birds and choose which set will be going to Fair.
3. Birds MUST be cared for by the Poultry Exhibitor/Parent ONLY.
4. Weigh-in for Market Birds will be held off-site on Wednesday, September 3, 2025, and will be scheduled with each registered exhibitor.
5. Birds Must come in at One Pair Per Cage.
6. Birds must remain in the Exhibitor's vehicle until weighers are ready for the next bird.
7. As a result of the 72 hour requirement all birds will be transported to the fairgrounds in one group.
8. ALL BIRDS MUST GO TO AN APPROVED DEPARTMENT OF AGRICULTURE PROCESSOR.
9. SUBSTITUTE SHOWMAN ARE NOT PERMITTED – The Exhibitor Must be the Handler of the bird for Judging and Sale Day.
10. Market Birds must be sold during the Youth Livestock Sale. Exhibitors must be on time and responsible for the movement of the Bird to the Sale Ring and back.
11. Exhibitors are responsible for the care of the Bird through load out on Saturday Afternoon.
12. All Birds Must go to an approved Department of Agriculture Processor.

CREATIVE NESTING BOX RULES

- 1. Poultry Display Pens must be used to create a nesting representation of the chosen breed.
- 2. Admittance to the Annex Building will be denied if the Entry contains **Any Type** of Bird Product.
- 3. Creative Nesting Boxes should be neat, creative, imaginative and fun.
- 4. A Photo or an item may be placed in the pen to add to the interpretation of the exhibit.

REALISTIC NESTING BOX RULES

- 5. Poultry Display Pens must be used to create a nesting representation of the chosen breed.
- 6. Admittance to the Annex Building will be denied if the Entry contains **Any Type** of Bird Product.
- 7. A photo or other item may be placed in the pen to add to the description of the exhibit.
- 8. Realistic Nesting Boxes must model as close as possible the real poultry nesting box of the chosen breed.
