ANGEL FOOD CAKE CONTEST RULES

1. Open to any individual amateur baker who is a Pennsylvania resident. One entry per person.
2. Entrants may **NOT** have won 1st place in this Angel Food Cake contest at any other fair in 2025.
3. The Cake and any Fillings and Frostings must be **made from scratch with edible ingredients**. No pre-packaged ingredients may be used (*ex: no pre-made mixes, cookie dough, pie crust, frosting, etc.*). Any decorations must just be edible.
4. The recipe shall include eggs that were produced in Pennsylvania, if possible.
5. The entire cake entry must be submitted for judging **on cardboard or other food safe disposable setting**. (*All pans, plates and dishes are considered to be disposable and will not be returned.*)
6. The Cake entry and its recipes will become the property of the Fair or PA Farm Show and will **not** be returned.
7. Recipe(s) listing the ingredients and the preparation instructions must be submitted with the entry (*printed on one-side of 8-1/2" x 11" size sheets of paper*). Entrant's name, address and phone number must be printed on the back of all the pages.
8. Refrigeration is NOT available at the Fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned, or otherwise distributed for consumption after judging for food safety reasons.
9. Judging will be based on the following criteria:

Flavor (aroma, taste, good balance of flavorings)	40 points
Inside Characteristics (texture & lightness)	30 points
Overall Appearance (surface, shape, size, color)	20 points
Topping, Icing, Decoration	10 points

BLUE RIBBON APPLE PIE CONTEST



INSTRUCTIONS TO BE USED BY FAIRS AT THEIR 2025 EVENT

Listed below are the criteria which we would like each fair to use in their contest. The certified first place winner from each fair will then have the opportunity to enter an apple pie in the BLUE RIBBON APPLE PIE CONTEST at the 2026 PENNSYLVANIA FARM SHOW.

RULES for local Fair and the PA Farm Show contests are as follows:

1. Open to any individual **amateur** baker who is a Pennsylvania resident. One entry per person.
2. **Entrants may NOT have won 1st place in this Blue Ribbon Apple Pie contest at any other fair in 2025.**
3. The Apple Pie, including fillings and crust, must be **made from scratch with edible ingredients.** No pre-packaged ingredients may be used (*ex: no pre-made mixes, cookie dough, pie crust, frosting, etc.*) Any decorations must just be edible.
4. Recipe **must include at least 60% apples in the filling.** It does not need to be a “traditional” two crusted apple pie and it can have a variety of fillings.
5. The entire pie must be submitted for judging in a food safe disposable pie pan. (*All pans, plates and dishes are considered to be disposable and will not be returned.*)
6. The Pie entry and its recipes will become the property of the Fair or PA Farm Show and will not be returned
7. The recipe for the pie and pie crust must be submitted with the entry. It should be submitted on one side of 8 ½” by 11” sheets of paper. The recipe must list all the ingredients, quantities, and the preparation instructions. Entrant’s name, address and phone number must be printed on the back side of all the pages.
8. Refrigeration is not available at the Fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after judging for food safety reasons.
9. Judging will be based on the following criteria:

Flavor	35 points
Filling (consistency, doneness, moistness & flavor)	25 points
Crust (color, flavor, texture, doneness)	20 points
Overall Appearance (surface, shape, size, color)	15 points
Creativity	<u>5 points</u>
TOTAL	100 Points

Creativity is essential to a varied competition. Do not limit your contest to a “traditional” two-crust apple pie. We are looking for a variety of fillings in the pies; the pie must include at least 60% apples in the filling.

Each Fair must submit the Contest Summary Report verifying the winning apple pie baker. This person will then be eligible to enter the state competition at the 2026 PA Farm Show and will receive the Official PA Farm Show Certification Entry Form directly from the PA Fairs Special Baking Contest Committee.

***NOTE:** If an individual has already won 1st place at another fair in 2025 for this Blue Ribbon Apple Pie contest, that individual is now considered qualified through that Fair to compete at the 2026 PA Farm Show and is no longer eligible to enter this contest at any upcoming Fairs.*

*First Place Winner is eligible for the **2026 PA Farm Show** competition.*

2025 HOMEMADE CHOCOLATE CAKE CONTEST

RULES:

1. Open to any individual **amateur** baker who is a Pennsylvania resident. One entry per person.
2. Entrants may **NOT** have won 1st place in this Homemade Chocolate Cake contest at any other fair in 2025.
3. The Cake and any Fillings and Frostings must be **made from scratch with edible ingredients**. No pre-packaged ingredients may be used (*ex: no pre-made mixes, cookie dough, pie crust, frosting, etc.*). Any decorations must just be edible.
4. Cake recipe **must feature chocolate or cocoa** as a main ingredient.
5. Entry must be a **layered chocolate cake**. **The finished overall size of the cake, including decorations, shall not exceed 12" high by 12" wide by 12" deep.**
6. Entry **must be frosted** and frosting must also be made from "scratch" (*no pre-packaged frosting*).
7. The entire cake entry must be submitted for judging **on cardboard or other food safe disposable setting**. (*All pans, plates and dishes are considered to be disposable and will not be returned.*)
8. The Cake entry and its recipes will become the property of the Fair or PA Farm Show and will not be returned.
9. Recipes must be submitted with the entry, printed on one side of 8-1/2" x 11" sheets of paper. Recipe must list all ingredients, quantities, and the preparation instructions. Entrant's name, address and phone number must be printed on the back side of all the pages.
10. Refrigeration is not available at the fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after judging for food safety reasons.

2025 PA Preferred® Junior Baking Contest Cookies, Brownies and Bars

RULES:

- Open to any individual **amateur** baker (ages 8 through 18 at the time of the fair's contest) who is a Pennsylvania resident. One entry per person.
- Entrants may NOT have won 1st place in this PA Preferred® Junior Baking contest at any other fair in 2025.**
- Entry must be **six (6) individual sized portions** of the baked entry item (cookies, brownies or bars).
- The Cookies, Brownies or Bars, and any fillings and frostings, must be **made from scratch with edible ingredients**. No pre-packaged ingredients may be used (ex: no pre-made mixes, cookie dough, pie crust, frosting, etc.). Any decorations must just be edible.
- At least two (2) PA Preferred® or locally produced ingredients must be used in the recipe. Some examples of qualifying ingredients include grains (*such as oats or flour*), butter, milk, eggs, fruits and/or vegetables.
- A PA Preferred® logo is not required** because not all PA Preferred® products carry the label. The name of the ingredient and the source is sufficient (*see attached example*). Contact RA-AGPAPreferred@pa.gov for any assistance with qualifying ingredients.
- Entry must be submitted for judging **on a food safe disposable setting**. (*All pans, plates and dishes are considered to be disposable and will not be returned.*)
- The PA Preferred® entry and its recipes will become the property of the Fair or PA Farm Show and will not be returned.
- Recipe(s) must be submitted with the entry, printed on one side of 8-1/2" x 11" sheets of paper. Recipe must list all ingredients, quantities, and the preparation instructions. **The name of each PA Preferred® ingredient or locally produced ingredient must be clearly listed along with the name of the source that made/grew the product** (ex: PA Preferred Milk – Galliker's brand; or Apples - Smith Farm Orchard). Entrant's name, age, address and phone number must be printed on the back side of all the pages.
- Refrigeration is not available at the fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after judging for food safety reasons.

Name of recipe: Ashlee's Apple Crisp Bars

Prep Time: _____ Bake Time: _____ Serves: _____

Ingredients

Shortbread Crust

- 1/4 cup brown sugar, packed
- 1/2 teaspoon vanilla extract
- 1 1/4 cups all-purpose flour
- 1/2 cup (1 stick) unsalted butter (PA Preferred, Lapp Valley Farm)

Apple Filling

- 4 cups apples, peeled, cored and thinly sliced (Smith Farm Orchard)
- 2 Tablespoons flour
- 1/4 cup sugar

Crisp Topping

- 1/2 cup brown sugar
- 1/4 cup sugar
- 3/4 cup flour
- 1 teaspoon cinnamon
- 1/2 teaspoon salt
- 1/3 cup chilled butter, cut into 1/2-inch cubes



Instructions

Shortbread Crust

1. Preheat oven to 350° F. Line a 9x9 pan with parchment paper, leaving extra hanging over the ends, spray with cooking spray.
2. In a large mixing bowl, beat together the butter and sugar until light and fluffy, about 2-3 minutes. Add vanilla and mix until combined. Add flour and mix until combined and dough is crumbly.
3. Press dough evenly into bottom of prepared pan. Bake for 12-14 minutes, until dough is slightly puffed. Remove from oven and set aside, maintain oven temperature.

Apple Filling

4. In a large bowl, combine apples, flour and sugar. Mix until apples are thoroughly coated. Arrange apples on baked crust.

Crisp Topping

5. In a medium bowl, mix together first five ingredients. With a pastry blender or two knives, cut in butter until mixture is crumbly. Spread topping over apples in an even layer.
6. Bake uncovered at 350° F for 45 minutes, or until topping is golden and apple mixture is bubbly. Let cool, lift apple crisp using the extra parchment paper at the ends as handles, and cut into bars.

RULES

- Power wheels should be taken to the livestock gate on Thursday **no later than 3:30** and they will be transported to grandstand area.
- Helmets **MUST** be worn. Bicycle helmets are permissible.
- Staff will attach Four (4) balloons will be attached to each vehicle.
- The object of this game is to pop all of the balloons on your opponent's vehicle while keeping your balloons intact.
- The last vehicle with the most balloon's left attached will be the winner.

GENERAL RULES FOR STOCK OR MODIFIED

1. Any regular electric Power Wheel is allowed.
2. All participants must be accompanied by an adult.
3. All doors and tailgates must be strapped shut. No sharp edges. You may use zip ties, duct tape or other flexible product to assist in keeping doors and tailgates shut.
4. Decorative changes can be made to the Power Wheel to make it resemble a derby car, however there can be no reinforcements to the power wheel. Changes and additions are decorative only.
5. Vehicles may NOT be raised or lowered. They must be the stock height that came when purchased.
6. If the vehicle has more than one speed, low speed must be used in both Stock and Modified.
7. Battery change is not permitted during the Demo.
8. If a child gets out of the Power Wheel during the event, that child is disqualified.
9. Passengers are not permitted.
10. Vehicles stopped for longer than 15 seconds will be considered inoperable, and will be disqualified.
11. Each heat will be given a 5-minute time limit. If at the end of the heat there is more than one contestant with balloons un-popped the heat will be declared a tie.
12. Please remember that this is for the kids.
13. Pictures of the participants might be used on social media.

Contest Director – Linda Berkibile

Day & Time To Be Determined - Please Check with Linda

1. **Rabbits being entered for this event must already be entered at the American Legion County Fair in either Department 9 or 10** and have successfully met the requirements of those respective departments.
2. It is recommended the rabbit be at least 4 months of age to compete, not bred or nursing offspring with the past 8 weeks.
3. Any handler showing unacceptable behavior toward their or any other animals will forfeit their awards/ placing. Unethical or In-Humane Practices are not permitted and will result in disqualification.
4. In the event a handler is not able to participate due to injury or illness, another handler may be assigned. However, the handler must be physically present during the run.
5. The handler must be supervising the rabbit at all times. The rabbit should never be tied to an object at any time.
6. The handler is responsible for the welfare of their rabbit. The American Legion County Fair will not be held responsible for any injuries that may occur during competition.
7. The handler is responsible for replacing any damaged equipment.
8. Show clothing should be neat and clean. Handler cannot wear heels, flip flops or heavy boots - Tennis Shoes are required.
9. H-style (clip on the neck strap and belly strap with a metal D-ring attached to the belly) harness no less than 3/8" in width are required. No vests, collars, figure 8 harnesses nor harnesses with the metal part at the rabbit's throat area are allowed.
10. Leashes must be at least 4 feet in length and no more than 6 feet in length with a metal snap hook are required. The leash is to be made from soft flat material no less than 3/8" wide. Retractable and elastic leashes are prohibited.
11. Leashes should hang loose whenever rabbits jump.

RABBIT AGILITY COMPETITION

AGILITY RULES

1. Rabbit agility combines rabbit hopping with obstacles commonly seen in dog agility (scaled down of course) such as the A-frame, bridge, hoops, tunnels and see-saws. The course can be run in a straight line, with turns or like a dog agility course set up over an area with a set order and way to do them.
2. All the same rules from hopping apply with the addition of the following that are specific per obstacle.
3. A frame: all 4 feet of the rabbit must touch both sides.
4. Bridge: 2 feet of the rabbit must make contact with the incline and decline. All 4 feet must touch the level part of the bridge.
5. See-saw: all 4 feet must touch both sides and the rabbit can not jump off until the ending side of the see-saw has made contact with the ground.
6. Hoop and tunnel: rabbit must go through and the handler must pass the leash through from one side to the other without knocking it over.

EXPLANATION OF FAULTS FOR AGILITY

- If the rabbit does not correctly complete an obstacle it counts as 1 fault.
- If the rabbit totally avoids the obstacle it counts as a fault. At this point the human team mate has the option to re-set the rabbit in front of the obstacle for 1 more chance however this takes time or continue going and take the fault with the quicker time.

As with hopping....THE FASTEST TIME WITH THE LEAST AMOUT OF FAULTS IS THE WINNER!

Remember, the turtle has proven slow and steady and can win the race.

RABBIT HOPPING COMPETITION

RABBIT HOPING RULES

1. The course will be set and reviewed the day of the contest.
2. Rabbits must be pre-registered by August 1st with entry fee paid. The event will be held on Thursday in the tent - the time is yet to be determined please see Linda Berkibile for details.
3. Three runs will be given on the course with the best score used. In the event of a tie, the competitor with the fastest time wins. Two competitors with the same number of faults and the same time participate in a run-off.
4. The rabbit must move through the course of its own free will. The rabbit may be guided in the right direction by the handler's hand. Use of the foot in any form, whether touching or blocking the rabbit, is not allowed. The rabbit should not be pulled or lifted by the lead at any time. The lead must not be used as a whip. Stomping or loud noises are prohibited, as this is defined as neglect/abuse. Rabbits must always be handled carefully so as not to cause them harm.
5. The rabbit that completes the course and commits the fewest faults wins. In the event of a tie, the competitor with the fastest time wins. Two competitors with the same number of faults and the same time will be tied in the standings. If standings are at issue the competitors in question must participate in a run-off.
6. Harnesses that have slipped can be adjusted during a timed run without stopping the time. Harnesses completely lost must be replaced without stopping the time. Rabbits must start again from the place, where the harness was compromised.
7. The handler is responsible for cleaning up any debris left by their rabbit on the competition course during a competition and in the warm-up area. Violation can result in exclusion from competition until the situation is resolved.

HOPPING FAULTS:

- Knocking down of a rail or entire jump by rabbit or handler is 1 fault regardless of the number of rails knocked down.
- Hopping around the jump, so that the lateral supports of a spread jump are passed.
- Knock down of an earlier jump or wrong jump by the handler or rabbit.
- Lifting a rabbit over a jump with all rails on.
- Three corrections give one fault.
- Starting before the judge indicates for a competitor to start. This is called a false start.
- The rabbit is lifted in its lead over a jump. First time a warning is given. Second time results in DNF from all subsequent runs and disqualification from the class.
- Refusal. The rabbit turns away from the jump or significantly hesitates before attempting the jump.

Department 22 (Open Class)

- Failure to pick the rabbit up at the end of the run.
- The handler deliberately takes an action that appears to be for the purpose of training the rabbit rather than trying to run the course correctly.
- The rabbit bites anyone at the event or any signs of vicious intent and the animal will be disqualified.

Multiple incidences will be reason to refuse the rabbit from future events.

1. A Written Essay (300 Words or Less) on the Topic, "What My Fair Means To My Community."
Judging Criteria: Content, Grammar, and Spelling. **[15 Points]**
2. Personal Interview: Each contestant will meet with a Panel of Judges.
Judging Criteria: Conversational Ability, Answers to Questions, Appearance/Poise, Activities and Knowledge of the Fair Industry. **[35 Points]**
3. Speech Presentation on the Topic, "Why You Should Come To My Fair". (A 3-5 Minute Timed Event) A Persuasive Speech appropriate for an audience of adults. The audience will be a panel of judges, parents, Fair members and other guests wishing to view the presentations. Props that enhance this speech are permitted, but not required. Contestants are judged on the effectiveness of their Public Speaking Skills, not on "Entertainment". Overhead projectors or PowerPoint presentations are not permitted.
Judging Criteria: Speech Content (Must Include Agriculture), Speech Format, Conveying A Message, Public Speaking Ability, Poise and Presence. **[30 Points]**
4. Evening Gown and Introduction: Each Contestant will make a Personal Introduction to the audience, similar to that which a Fair Queen would give when visiting a Fair or other public event. Each Contestant has 15 seconds to make this Introduction.
Judging Criteria: Speech Content, Stage Presence and Appearance. **[20 Points]**

Local and State Fair Queen Dress Code:

Wearing of the Fair Queen Crown and or Sash is to be considered an honor and privilege. The bearer is now an ambassador representing herself, her family, her community and our Fair.

While fashion styles may change, good taste does not!

Therefore responsible, appropriate and professional appearance is expected while wearing the Crown and Sash:

1. Attire that is conducive to the specific appearance of the event (i.e. business casual, formal, etc.)
2. No jeans, sneakers, flip flops or boots. Alterations may be made to this rule only if approved by the Fair Queen Coordinator
3. It is strongly recommended that closed toe shoes be worn in the livestock areas, for safety reasons.
4. No visible piercing (other than earrings) or tattoos.
5. No outfits that are too low cut, too short or too revealing.
6. Dresses/skirts must be no shorter than the height of a dollar bill (approx. 2.5") from the bottom of the hem line to the top of the knee cap.
7. No clothing that advertises, promotes, or glorifies the use of alcohol, tobacco, drugs, or anything inconsistent with the dignity of the Fair Queen Program.

Local and State Fair Queen Behavior Policy:

The Contestant's governing Board shall have the sole discretion to determine whether, in its judgment, the Queen, Alternate or Contestants may continue to participate in the Program. If the Board determines that any statement or representation is not true and accurate, or that any action is inconsistent with the rules, standards and dignity of the Program, it will be grounds for immediate dismissal.

The following will be considered violations of the Policy and will be grounds for immediate disqualification, dismissal and/or being banned from future Queen Competitions.

1. Any infraction of any Queen Contest Rule.
