Fitting Rule For All Livestock Entered In Fair Will Be Bath/Blow/Brush (Only).

It Is Your Responsibility As An Exhibitor To Read And Be Aware Of All Rules And Regulations As Set Forth By The Pennsylvania Department of Agriculture And the American Legion County Fair

1. Late Registration will not be accepted unless arrangements have been made with the office
2. Each Exhibitor is responsible for Lanyard Registration. Lanyard information may be found at the front of this book in the Rules and Regulations.
3. Sheep showing clinical signs of contagious, infectious or external parasitic disease including foot rot and sore mouth will not be admitted.
4. All sheep must be USDA tagged or USDA tattooed as recognized in an approved USDA Scrapie Database.
5. This identification must be listed on the Certificate of Veterinary Inspection (CVI) completed within 30 days of check-in Health Certificate.
6. The Flock of Origin including sheep consigned to a show shall be examined by an accredited Veterinarian. The Vet must prepare the original Health Certificate (BAI-13) and must state on the Health Certificate that he/she examined the entire flock and found no evidence of contagious, infectious or external parasitic disease. The date of the examination must also appear on the Health Certificate within 30 days of the show.

7. All sheep from other states must be accompanied by an Interstate Health Certificate issued by an accredited Veterinarian indicating that the entire flock was examined for health within 30 days.
8. Exhibitors must produce a Breed Certificate at check-in for sheep that are being shown as Purebreds.
9. Any animal of unthrifty nature, unsuitable condition, or which cannot be satisfactorily handled under show conditions must be removed from the fairgrounds.
10. All washing and show preparation will take place in the Sheep Barn Wash Pen, Fitting Pen or Side Arena ONLY. Beef wash racks are not to be used unless given permission by the superintendent who will monitor the activity.
11. Sheep are not permitted at Campers and exercise will only take place in the Large Tent across from the barn.
12. All stalls must be cleaned daily and upon the exit of your animal. Superintendents will not take on this responsibility. Failure to comply will result in Premium Checks being held until the issue is resolved.
13. Entries will be released from the barn at 7:00 pm the last Saturday of fair week.
14. **DUE TO LIMITED SPACE EXHIBITORS ARE ONLY PERMITTED 2 ANIMALS PER CLASS**
